## Platform Vision

## Core Platform Features

Artist profiles, unlimited uploads, music video hosting, release scheduling, project-based promotion, collaboration tools, and integrated analytics are all delivered in a unified dashboard.

## Royalty Structure

Artists receive transparent royalty reporting and automated revenue splits. Ownership confirmation is required for all uploaded audio.

## Security Framework

The platform applies modern security practices including encrypted data storage, secure transmission, authentication controls, and content protection mechanisms.

## Current Platform Metrics

As of 2025, TrapGod supports approximately 800 registered users, a growing catalog of uploaded music, and one active official artist group known as the TrapGod Artists Collective. The platform emphasizes accuracy and transparency in all reported metrics.

## Roadmap

Planned expansions include additional artist groups, advanced analytics, expanded distribution support, fan engagement tools, and scaling infrastructure as adoption grows.
